2.	Powder coated Aluminium window frame of 16 gauge (Window frame, glass where required, bolts, tower bolts, beading with gaskets, of approved shade)
3.	Branded Door Closer

5. The College reserves their right to negotiate the quoted prices with L1 bidder before award of work.
6. Payment terms: Full and final payment will only be made after successful completion of each work and on submission of working satisfactory report in this regard.
7. The bidder shall remain valid for acceptance for a period of 180 days from the date of work order.
8. The payment will be made to the firm at any Bank Account maintained in India by way of NEFT/RTGS after statutory deductions as applicable laws.
