The College at its discretion may change the quantity, upgrade the criteria, and drop any item or part thereof at any time before or after placement of the order.
4. The College also reserves the right of splitting the items/ work within two or more contractors for placement of order.
5. The College reserves their right to negotiate the quoted prices with L1 bidder before award of work.

6. Payment terms: Full and final payment will only be made after successful completion of each work and on submission of working satisfactory report in this regard.
7. The bidder shall remain valid for acceptance for a period of 180 days from the date of work order.
8. The payment will be made to the firm at any Bank Account maintained in India by way of NEFT/RTGS after statutory deductions as applicable laws.
