Sealed Quotations are invited from bonafide and experienced service providers for **Hiring of tent and related accessories** at Sri Guru Nanak Dev Khalsa College for organising various events of the college. The sealed bids in given format should reach the office of the undersigned on or before 1st April, 2024 by 1:00 PM.

Detailed description of tent and related accessories required is provided in **Annexure I** which can be used for preparing the financial bid.

Terms and conditions

1. The bid shall remain valid for a period of one year which may be further extended to another year. The institute may accept or reject any or all bids in part or in full without assigning any reason and does not bind itself to accept the lowest bid.
2. The college, at its discretion, may change the quantity, upgrade the criteria, and drop any item or part thereof at any time before or after placement of the order.
3. The institute also reserves the right of splitting the items within two or more contractors for placement of order.
4. Bidder is advised to visit the site to fully understand the area and ascertain the difficulties that may be encountered during execution of works and for obtaining all information for himself on his own responsibility that may be necessary for preparing the bid and entering into Contract. The site visits shall be entirely at bidder's own expense. Once the bid is submitted, it will be presumed that the bidder has visited the site and no changes will be entertained in the quotation.
5. The successful Bidder shall insure all the materials for transit upto destination & during the rented period & removing the all materials & clearing the site. The rate quoted by the firm shall be inclusive of complete all such charges.
6. The bidder & his/her authorized representative/ supervisor are responsible for ensuring the workers comply with the safety rules at work & use of safety harness.
7. Payment terms: Full and final payment will only be made after the completion of services and on submission of a satisfactory report in this regard. The payment will be made to the firm at any Bank Account maintained in India by way of NEFT/RTGS after deducting the TDS as applicable. The bidder should provide the correct account details in the financial bid for the same.
8. The quoted price shall be inclusive of GST, Sales Tax, Service tax and all other taxes (if applicable).

9. The Financial bid should be submitted in a sealed envelope. On top of the envelope, **“Quotation for Hiring of tent and other accessories”** should be duly super-scribed.
